County Convention: 1st Vice President Darrin Smith gave a report on the convention up to date and what will be happening for the duration of the convention. After a long discussion all these ideas have been turned over to the rules committee to look over and report back to the membership with their recommendations.

Old Business: The Cherry Tree Fire Company has been dropped from the roster due to the lack of payment of their dues in accordance to the by-laws.

New Business: President Cox read a letter from Lakemont Volunteer Fire Company and forwarded it on to the membership committee to review. William Cornell of West Hills Regional submitted a proposed by-law change. Article II officers and their elections.
