2019-2020 was not busy due to the COVID-19 pandemic and compared to our previous year for the Certification Committee and staff. We conducted three (3) tests over the past fiscal year from July 1, 2019 – June 30, 2020, for which we tested 37 candidates. The break down in each discipline is as follows:

- 37 Fire Fighter I (last candidate # 1482)
- 0 Fire Fighter II (last candidate # 407)
- 0 Haz-Mat Awareness (last candidate # 212)
- 0 Haz-Mat Operations (last candidate # 154)
- 0 Pumper Driver Operator (last candidate # 010)

On November 14, 2019; committee members Bill Cornell, John Hawksworth and Eric Miller attended the mandatory Test Site Certification meeting in Lewistown.

An evaluator's workshop was conducted on Saturday March 10, 2020 at Dauntless Fire Station. Twenty-Three (23) evaluators participated in the annual workshop.

The following tests are scheduled for the remainder of the year:

- 1. Firefighter II Open Test: October 10, 2020
- 2. Firefighter I Open Test: October 16 & 17, 2020

The 2020 Test Site Coordinators and Pro-Board meeting are scheduled for November 5, 2020 in Lewistown pending any pandemic issues. The financial report was submitted to the Audit Committee.
