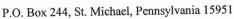

#### Fire Training Report

The Cambria County Regional Firefighters Association sponsored 5 Essential Programs, these programs started in January and continued through May. These programs were a huge success and put training Firefighters on the street throughout Cambria, Indiana, Blair, Clearfield, Somerset, Huntington, and Allegheny Counties.

The "Leadership Academy" was offered again this year. It was comprised of 16 individual programs all done via zoom. 265 Students took advantage of these programs with more than 2400 certificates issued. Bucks County Community College was key in

supporting these programs.

The annual County Fire School was held this year. Classes were held over three weekends in April. All classes were held either at the Cambria Heights High School or the Fire School Site.

The Training Committee along with the Site Committee worked together again this year to open the Fire School Site in the evenings, during the week, for department training. The Training Committee was fortunate to be offered, through Bucks County Community College, an opportunity to have its current Suppression Instructors certified as "Live Fire Instructor" and "Live Fire Instructor in-charge". We completed this national certification July 24 and are the only site outside the Philadelphia Fire Dept. Training Academy who have instructors certified to this level.

A special thanks to the Training Committee, the Site Committee, the Officer of the Association, Cambria County Commissioners and all the others who continue to support training in Cambria County.

- 3. Firefighter II Open Test: October 1, 2022
- 4. Firefighter I Open Test: October 7 & 8, 2022

Note: Excelsior VFC (Bellwood, PA - Blair County) expressed interest in doing a Closed FF-1 & FF-2 test.

The 2022 Test Site Coordinators and Pro-Board meetings will be held sometime in November 2022 in Lewistown and/or via teleconference. The financial report was submitted to the Audit Committee.

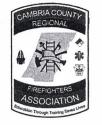
